

Lifeline SPAC I Plc Data Protection Notice – Extraordinary General Meeting

This data protection notice describes the personal data processing related to Lifeline SPAC I Plc's Extraordinary General Meeting.

2. Name of the register

Lifeline SPAC I's Extraordinary General Meeting register.

3. Purpose and legal basis for the processing of Personal Data

The purpose of processing of personal data is to enable the shareholders of Lifeline SPAC I to register for and participate in the Extraordinary General Meeting of shareholders to be held on 23 August 2024.

The personal data is used only for purposes necessary to organize the Extraordinary General Meeting, such as verifying of the shareholders' identity and his/her right to attend the Extraordinary General Meeting, preparing a list of participants, a list of votes and ballots, as well as for organizing any polling, managing questions asked in advance and controlling requests to speak.

A list of participants as well as the poll results summary will be prepared to be attached to the minutes of the Extraordinary General Meeting.

Innovatics Ltd is the technical service provider of the registration and advance voting system. The shareholder's register is maintained by Euroclear Finland Oy.

The legal basis for the processing of personal data is in particular the compliance with the legal obligations to which Lifeline SPAC I is subject, based on the Finnish Companies Act (624/2006) and other legislation. Personal data may also be processed on the basis of legitimate interest of Lifeline SPAC I or a third party, in which cases the legitimate interest is in particular justified purposes related to the business of Lifeline SPAC I, such as administrative activities, ensuring of physical security, protection of property, investigation of misuse, as well as potential merger and acquisition activities.

The provision of personal data as specified in this Data Protection Notice is necessary in order for Lifeline SPAC I to fulfil its legal obligations. Should the data subject not provide his/her personal data to Lifeline SPAC I as described in this Data Protection Notice, the sending and handling of the shareholder's registration is not possible, which means that the data subject cannot participate in the Extraordinary General Meeting.

4. Processed personal data

The processed personal data consists of shareholder's and his/her representative's (if any) name, personal identity number and/or business ID, address, contact details, number of shares and votes, voting information, method of identification, basis of representation, date of registration, and information on assistant (if any), proxy, questions asked in advance and any other additional information provided during the registration process. In addition, the participants' time of arrival and exit will be recorded. For the technical maintenance and monitoring of the service also the log information on registration and voting as well as the IP-address of the user will be recorded.

Register contains Euroclear Finland's shareholders' register at the record date, which contains e.g. the name of the shareholder, business or personal identification number, address and the number of shares.

Register contains Euroclear Finland's temporary list of nominee registered shareholders, which have registered to participate in the Extraordinary General Meeting, and the number of their shares.

5. Regular sources of data

Personal data is mainly collected from the shareholder himself/herself or from his/her representative in connection with the registration. When registering via email, mail, or telephone, the personal data and advance votes are entered in the register by Lifeline SPAC I or Innovatics Ltd.

The registration system retrieves the shareholder's data based on the given personal data from the shareholders' register on the record date of the Extraordinary General Meeting maintained by Euroclear Finland Oy.

Innovatics Ltd enters the information about the voting instructions of holders of nominee registered shares.

6. Disclosures and transfers of personal data

In accordance with the Finnish Companies Act, a shareholder's register on the record date, which contains name of the shareholder, municipality as well as number of shares and votes will be kept available at the Extraordinary General Meeting. Register also contains information on the temporary listed nominee registered shareholders.

Lifeline SPAC I may disclose personal data to competent authorities when required to do so under the applicable laws, to prepare for legal proceedings or to defend a claim within the limits permitted or required by the applicable laws from time to time. If Lifeline SPAC I reorganizes its business, personal data may be disclosed to the purchaser candidates and their representatives in accordance with the applicable law from time to time.

Lifeline SPAC I may use service providers in the processing of personal data described in this Data Protection Notice and may transfer personal data to such service providers to the extent necessary in order for them to provide the services agreed to Lifeline SPAC I.

Personal data may be transferred to countries outside the EU or the European Economic Area (EEA). In such cases, Lifeline SPAC I will ensure the adequate level of data protection. Information on transfers of personal data outside the EU or EEA area and on the appropriate safeguards applied thereto is available from the contact person mentioned in Section 1 above.

For recipients with Finnish phone numbers, text messages are sent via a Finnish service provider. For those with international numbers, text messages are sent using a Swiss service.

If it's possible to use the right to speak virtually in the Extraordinary General Meeting, the right to speak will be enabled by a US service provider¹. In this case, the aforementioned service provider processes the IP address and name of the person using the right to speak.

Otherwise, personal data is not transferred or disclosed outside the EU or the European Economic Area.

7. Protection of the personal data

Non-digital data is kept in a locked space and is available only for authorized persons.

Digital data is stored in a data center that meets the requirements for processing personal data. Data connection between the user's browser and the server is encrypted. Access to the system is limited to those employees of Lifeline SPAC I and its subcontractors who need and process the information for arranging the Extraordinary General Meeting.

8. Retention and deletion of the personal data

Innovatics Ltd stores the personal data for a maximum of one year after the Extraordinary General Meeting.

Euroclear Finland stores the data for a maximum of four months.

Personal data entered into or attached to the minutes of the Extraordinary General Meeting will be retained as defined in the Finnish Limited Liability Companies Act (624/2006) for an indefinite period of time. Other personal data will be destroyed in a secure manner after they are no longer necessary for the preparation of the minutes or the verification of its validity.

9. Rights of the data subject

The data subject may use the rights related to the processing of his/her personal data specified below with regard to Lifeline SPAC I. The exercise of the rights is a personal right of the data subject and requires identification.

- Right of access: The data subject has the right to obtain a confirmation from Lifeline SPAC I on whether Lifeline SPAC I processes personal data concerning the data subject, as well as the right to access such data. Lifeline SPAC I may request the data subject to specify his/her request, amongst others, with regard to the details of the data to be delivered.
- Right to rectification: The data subject has the right to obtain from Lifeline SPAC I the rectification of inaccurate personal data concerning him/her processed by Lifeline SPAC I, and to have incomplete personal data processed by Lifeline SPAC I to be completed.
- Right to be forgotten: The data subject has the right to obtain from Lifeline SPAC I the erasure of personal data related to him/her. Lifeline SPAC I has the obligation to erase such data in case there is no longer a legal ground for the processing of such data and the legal obligation binding Lifeline SPAC I related to the storing of the personal data has terminated.
- Restriction of processing: In certain cases prescribed by law, the data subject has the right to obtain from Lifeline SPAC I restriction of processing of his/her personal data.
- Right to object to processing of personal data: In certain cases, the data subject may have the right to object to processing of his/her personal data. The right to object is applicable in such situations in particular where the processing of personal data is based on the controller's legitimate interest. In such situations, Lifeline SPAC I has to comply with the data subject's request, unless Lifeline SPAC I demonstrates compelling legitimate grounds for the processing, which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims.

The requests shall be directed to the contact person mentioned in Section 1 above.

The data subject has the right to lodge a complaint with the competent supervisory authority if he/she has any remarks regarding the processing. The related instructions of the Data Protection Ombudsman can be found on the website of the Data Protection Ombudsman at <https://tietosuoja.fi/en/home>.
